 electronic sign. Staci suggested a small marquee or scrolling sign. Staci will look for
 information in regards to different signs.
- Racheal suggested text notifications to citizens about events in the town.
- Kelly suggested fish education/information signs for the fishing pier.
- Events committee the committee would like to hold an event for every holiday. Easter event and Founder's Day is planned to be held at the Howey Mansion.
