 - We all agree that Howey in the Hills needs an Instagram.
- Pat will order the benches for the basketball court.
- Electronic sign – Howey PD is working on a grant that could go towards an electronic sign. In addition, impact fees can go towards an electronic sign. Right now P&R has about \$199,000 in impact fees.
 - Currently our sign ordinance prevents an electronic sign. This ordinance can be amended.

New business:

- Make a "Trick or Treat" map for Halloween of houses that will participate in giving out candy for Halloween.
