1. Consideration and Approval of the September 23, 2021, Planning and Zoning Board Meeting minutes.

Chairperson Tina St. Clair read the Ordinance 2021-008 by title only:

2. Consideration and Recommendation: **Ordinance 2021-008**

**AN ORDINANCE OF THE TOWN OF HOWEY-IN-THE-HILLS,
FLORIDA PERTAINING TO HOME-BASED BUSINESSES; AMENDING
SECTION 68-2 OF THE TOWN'S CODE OF ORDINANCES AND
DELETING SECTION 5.01.02 OF THE TOWN'S LAND
DEVELOPMENT CODE REGARDING HOME OCCUPATIONS TO BE
CONSISTENT WITH THE NEW GENERAL LAW ON HOME-BASED
BUSINESSES; PROVIDING FOR SEVERABILITY,
CODIFICATION AND AN EFFECTIVE DATE.**

Tom Harowski, Town Planner, introduced the item and gave an overview of the proposed ordinance.

3. Consideration and Recommendation: Comprehensive Plan Amendment – Property Rights Element

Town Planner, Mr. Harowski, outlined the property rights elements of the Comprehensive Plan Amendment.

Zach Huebner of Eagle Homes answered questions about the plans that he has submitted.
