The 2 inch hydrant meter and back-flow preventer is used on a temporary basis, usually for construction site. The rental fee and deposit is a minimum of \$1,600.00 with 50 percent being refundable upon return of the nondamaged and fully functional meter and back-flow preventer. A 50 percent nonrefundable fee covers the cost of installation and maintenance of the meter and back-flow preventer.

Planning

Zoning and development application fees

- a) Establishment of administrative procedures. The following administrative procedures shall be utilized when collecting and processing all zoning and development review fees and deposits paid to the Town of Howey-in-the-Hills:
1. Minimum fees. A minimum fee shall be collected from each applicant by the Town Clerk at the time of filing each application for zoning permit issuance, site plan approval, subdivision plat approval, conditional use, variance, special exception, rezoning, planned unit development approval, amendment to the land development regulations, annexation, or comprehensive plan amendment or upon filing an appeal. No application shall be accepted until the fee is paid in full.
 2. Processing fees. In addition to the minimum fee collected at the time of application, the applicant shall be billed monthly for all amounts expended by the town in processing the application or appeal which exceed the minimum fee, including, but not limited to, amounts expended for staff time, engineering fees, attorney's fees, publication costs, copy charges, and telephone charges. Failure by the applicant to pay these excess charges within ten days of billing shall result in all work ceasing on the application until such time as the bill is paid. Failure of the applicant to pay these excess charges within 30 days of billing shall cause the application to be void, and a new application and minimum fee must be submitted prior to any further town action.
- b) Establishment of minimum fees: The following minimum fees are established for the services indicated:
