Dear Ms. Burke;

WCA is pleased to be the solid waste and recycling service provider for the Town of Howey and I am amazed that a year has already gone by. I hope that WCA is not only meeting, but exceeding the expectations for the Residents, the Town Council and the Staff of Howey.

In section 10.2 (a) of our contract, adjustment to rates, the Contractor may petition the city council annually for an annual CPI increase which shall not be unreasonably denied. The CPI for 2017, as reflected in the attached table, is 3.1%.

The calculation for the residential collection rate increase for FY 2017/2018 is 3.1% times the current residential rate which equates to an increase of \$.49 per home per month for a new rate of \$15.92. WCA would also like to request the Town's consideration of dropping the performance bond in its entirety. WCA has established itself within the Town's community and has the desire to maintain a long term partnership with the Town. See attached pricing matrix for the adjusted rate schedule.
