Lake-Sumter MPO Advisory Board Information & Meeting Dates

The Bicycle Pedestrian Advisory Committee (BPAC) is a formal advisory body to the Lake-Sumter Metropolitan Planning Organization (LSMPO). BPAC is a committee appointed by the LSMPO Board members from a broad base of professionals and concerned citizens, whose mission is to advise the LSMPO Board on bicycle and pedestrian issues. Also the committee is to assist the LSMPO Board in the formulation of goals and objectives for shaping the urban and rural environments through the effective planning for bicycle and pedestrian facilities.

BPAC appointments can be citizen, staff member, or elected official; however, elected official cannot also be appointed to the governing board.

The CAC is comprised of interested community members. Therefore, this committee has a special advisory role to the MPO because it provides a necessary communication link between the MPO and the community it is serving. Thus, the input provided by the CAC insures that the MPO planning process is actually meeting the needs of the community it is serving.

CAC appointments to be citizen only.

The TAC is comprised of planners and engineers from the various local governments comprising the MPO. Therefore, the input provided by the TAC is of a very technical nature. This may include making technical design recommendations and verifying that all documents conform to the appropriate standards.
