The current year tentative millage:	9.2750 mills
The current year roll-back rate:	9.3369 mills

-0.66%	

Mayor Sears read by Title Resolution No. 2016-004 – Tentative Millage Rate

Councilor Conroy, seconded by Councilor Mabry moved to adopt Resolution No. 2016-004, Tentative Fiscal Year 2016/2017 Millage Rate. Motion carried 5-0 with a roll call vote.

The Rolled Back Rate is: 9.3369 mills
The Percentage of change over the roll-back rate is: -0.66%
The Tentative Millage Rate to Be Levied Is: 9.2750 mills

Mayor Sears read by title Resolution No. 2016-005 – Tentative Budget

Mayor Sears asked for public comments and questions.

Marie Gallelli, 1104 N tangerine Ave, asked when the new Fiscal year starts.

Mayor Sears replied October 1, 2016 to September 30, 2017.

Councilor Kearney, seconded by **Mayor Pro-Tem David Nebel** moved to approve Resolution No. 2016-005, Fiscal Year 2016/2017 Tentative Budget. Motion carried 5-0 with a roll call vote.

Mayor Sears announced that the Public Hearing for the adoption of the fiscal year 2016/2017 Tentative Millage Rate and Tentative Budget is now complete.
