Councilor Nebel, seconded by Councilor Mabry, moved to approve the Consent Agenda as presented. Motion carried 5-0 with a roll call vote.

### NEW BUSINESS

Consideration and Approval of Proposal from Lem Bryant Land Clearing in the amount of \$5,670.00 for dewatering and excavation for inlet and provide and install type C bubble up inlet, back fill and dress out site where on N. Lakeshore Blvd. where drainage has collapsed

Mayor Sears gave background on this item. A lengthy discussion ensued.

**Councilor Conroy**, seconded by **Councilor Nebel**, moved to approve the proposal from Lem Bryant Land Clearing in the amount of \$5,670 for dewatering and excavation for the inlet and provide and install Type C Bubble Up Inlet, back fill and dress out the site on N.
