### **NEW BUSINESS**

Consideration and Approval of Re-Employment Connection Worksite Agreement with Work Force of Central Florida

Town Clerk Brasher gave detailed background on the item.

<u>Councilor Ormsbee</u>, seconded by <u>Councilor Nebel</u>, moved to approve the Re-<u>Employment Connection Worksite Agreement with Work Force of Central Florida</u>. <u>Motion carried 4-0 with a roll call vote</u>.

Discussion: Legal Counsel representation at monthly Town Council Meetings

**Mayor Sears** gave detailed background on this item and proposed to not have legal counsel at the council meetings to save approximately \$12,000 as the budget is over approximately \$12,000 this year. He further stated if the Council gives his authorization to base it on a meeting by meeting basis.

**Councilor Ernest** said he would be in favor of authorizing Mayor Sears to make the decision for legal council to be present. **Mayor Sears** stated that Town Attorney is available via telephone during the meetings if needed. Discussion ensued. **Councilor Nebel** said she would be uncomfortable with not having legal counsel present at the meetings.

Councilor Ernest, seconded by Councilor Ormsbee, moved to have legal counsel attend the first meeting of each month unless Mayor Sears feels the legal counsel attendance is not necessary. Motion carried 4-0 with a roll call vote.

Mayor Sears asked for the agenda to be amended to take action on the Interlocal Agreement for the CDBG.

<u>Councilor Ormsbee</u>, seconded by <u>Councilor Nebel</u>, moved to amend the agenda to <u>take action on the Interlocal Agreement for the CDBG</u>. <u>Motion carried 4-0 with a roll call</u> vote.

**Mayor Sears** gave detailed background on the item and said Town Engineer Shira has reviewed the document as well as Town Clerk Brasher.

Councilor Ernest, seconded by Councilor Nebel, moved to approve the Community

Development Block Grant Interlocal Agreement between Lake County and the Town of

Howey-in-the-Hills for Water Treatment Plant Upgrade, Phase 1. Motion carried 4-0

with a roll call vote.
