NEW BUSINESS

Discussion: California Boutique Wines, Inc. Promotional Wine Tasting Event to be held December 12, 2009

Roosevelt Shannon gave background on this item and said all legal documents will be in place before the Wine Tasting Event or the event will not be held. **Lt. Thomas** gave legal information on alcoholic beverage samples and sales. Procedures of the wine tasting were discussed.

Del Pearce voiced his opinion on the date of this event.

Discussion: Water Plant Improvements and Financial Plans Update

Mayor Sears gave background on this item. Town Engineer Shira presented a layout design of the proposed water plant expansion. Financials for the water plant expansion were discussed. Mayor Sears said the State Revolving Fund (SRF) loan documents are ready to be signed and returned for the pre-construction portion of the project. There will be debt service for that portion of the expansion project once the loan documentation is submitted. Discussion ensued.

Discussion: Public Works Vehicle

Mayor Sears gave background on the need for the current vehicle to be repaired or to trade in two (2) un-operational vehicles for a 2003 Ford pick-up truck from Ramos Auto Repair. Discussion ensued.

Councilor Ernest, seconded by Councilor Crowder, moved to authorize the purchase of the Ford F150 from Ramos Auto Repair which includes the trade-in of the two (2) non-operational vehicles. Motion failed 2-2 with Councilor Nebel and Mayor Sears voting no in a roll call vote.

Mayor Sears discussed his proposed goals and said he would like specific goals for 2010 from the Town Council, Town residents and Department Directors.

Discussion: F.D.O.T. Public Workshop for SR 19 Bridge Maintenance Plan and Process

Town Clerk Brasher gave an update on the Public Meeting to be held on January 14, 2010 at 5:00 p.m. which will be held at the Lake County Agriculture Center located at 1951 Woodleaf Road in Tayares.
