**Town Planner Shira** said there was a change in one element but the change was not made in another element, which makes the proposed plan inconsistent. The items will be changed to be consistent. **Ms. Shira** gave additional background on Policy 1.6.43, Land Use Allowed within Wellfield Protection Zones.

Mayor Pro-Tem Nebel, seconded by Councilor Crowder, moved to amend the EAR Based Amendment in Policy 1.6.3 the Future Land Element and Policy 4-3.14 Public Facilities Element for consistency. Motion carried 4-0 with a roll call vote.

Councilor Ernest, seconded by Councilor Crowder, moved to adjourn the Land Planning Agency Meeting at 6:40 p.m. Motion carried 4-0 with a roll call vote.

Mayor Sears reconvened the Town Council Meeting at 6:41 p.m.

#### **NEW BUSINESS**

Consideration and Approval of Urban and Community Forestry (U&CF) Grant Memorandum of Agreement.

**Chairman Richardson** gave detailed background on this agenda item and presented a hand-out of the tree locations. Discussion ensued.

Mayor Pro-Tem Nebel moved to approve the Urban and Community Forestry Grant with the Public Works Department to maintain the trees with the oversight of the Mayor. Motion died due to a lack of a second.

Councilor Crowder, seconded by Councilor Ernest, moved to approve the Urban and Community Forestry Grant Memorandum of Agreement. Motion carried 4-0 with a roll call vote.

## **Parks and Recreation Update**

**Chairman Richardson** asked permission to hold an Oktoberfest at the park and to authorize beer to be served. Discussion ensued.

Roger Burgoyne, representing Howey Men's' Club, said they were going to hold the event at Mission Inn, however, Mission Inn is not available in October.

<u>Councilor Ernest,</u> seconded by <u>Councilor Crowder</u>, moved to approve the <u>Howey Men's Club plan and host an Oktoberfest at Griffin Park.</u> Motion carried 4-0 with a roll call vote.

It was the consensus of the Town Council to authorize the Howey Men's Club to hold an Oktoberfest at Griffin Park and to come back to the Town Council with the date and all event information.

**Chairman Richardson** further asked if a newspaper recycliying container can be placed at the Police Department, which would be a fund raiser for the Parks and Recreation Advisory Board.

Denise Gainer gave detailed background on the newspaper recycling program.

Councilor Nebel, seconded by Councilor Crowder, moved to approve the recycling program. Motion carried 4-0 with a roll call vote.

Resolution 2010-009, SRF Loan Proceeds

**Mayor Sears** gave detailed background on this item and said the Town will reimburse themselves from the SRF loan proceeds. **Councilor Crowder** asked numerous budget related questions about the SRF loan.

<u>Councilor Ernest, seconded by Mayor Pro-Tem Nebel, moved to adopt Resolution No. 2010-009, SRF Loan Proceeds. Motion carried 4-0 with a roll call vote.</u>

Resolution 2010-010, Authorizing the City of Clermont to Participate in the Interlocal Service Boundary Agreement with the City of Groveland.

**Town Attorney Blom-Ramos** read by title only, Resolution No. 2010-010, Invite the City of Clermont to participate in the Interlocal Boundary Service Agreement with the City of Groveland. **Mayor Sears** gave background on this item and he is looking for a member of the Town Council, Planning and Zoning Commission or a Staff member to attend these meetings. **Councilor Crowder** said he felt an elected official should attend the meetings. **Town Attorney Blom-Ramos** said the City of Groveland would like a list of discussion items.

Councilor Crowder, seconded by Mayor Pro-Tem Nebel, moved to adopt Resolution 2010-010, Authorizing the City of Clermont to Participate in the Interlocal Service Boundary Agreement with the City of Groveland and for an elected official and an appointed Planning and Zoning Commission member to attend the meetings. Motion carried 4-0 with a roll call vote.

Set Tentative Millage and Tentative Budget Public Hearing Dates Discussion ensued.

**Councilor Crowder** said he felt the shortage should be found in the Police Department budget and noted areas in their budget where he felt there would be money to pay the pension shortage.

No. 2010-007, Water Facilities Plant Expansion Fee in the amount of \$10.00 per month.

Motion carried 3-1 with Councilor Crowder voting no.

Resolution 2010-006, Repealing Resolution 2007-002, Relating to a \$5.00 Stormwater Maintenance Fee

**Mayor Sears** read by title only, Resolution No. 2010-006, Relating to a \$5.00 Stormwater Maintenance Fee.

The Public Hearing was opened. As no one wished to speak, the Public Hearing was closed.

Mayor Pro-Tem Nebel, seconded by Councilor Ernest, moved to adopt Resolution No. 2010-006, Relating to Repealing the \$5.00 Stormwater Maintenance Fee. Motion carried 4-0 with a roll call vote.

**Councilor Crowder** asked what the reason was for adopting this fee as now the Town is repealing this fee. **Mayor Sears** said for stormwater projects and now the water plant expansion is necessary so the funds are reallocated.
