15	Council each year for an annual Consumer Price Index "CPI" adjustment which shall not be		
16	unreasonably denied.

18 19	Whereas, Sec. 100-10.3 of the Town's Code of Ordinances requires that fees for the		
20	collection and disposal of refuse shall be as provided for by the Town by ordinance.

24	Section 1. Recitals. The recitals set forth above are true and correct and constitute the		
25	legislative findings of the Town Council.

27	Section 2. Adjustment to the WCA Solid Waste and Recycling Rates. The rates for solid		
28	waste and recycling are hereby increased by 52 cents per home for a new monthly rate of \$16.86.		
29	This increase is based on the CPI for 2019 which is 3.2%. The rates will be increased as of		
30	October 1, 2019.

32	<b>Section 3. Severability.</b> The provisions of this Ordinance are declared to be separable and if		
33 34	any section, sentence, clause or phrase of this Ordinance shall for any reason be held to be		
35	invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, sentences, clauses or phrases of this Ordinance, but they shall remain in effect, it being the		
36	legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.
