Janice Mclain, 109 S Lakeshore Blvd. – Mrs. Mclain had a question about how this would affect snowbirds who currently are shutting off their water several months during the year and are not paying Solid Waste when their water is turned off. Mayor MacFarlane stated that this would affect those residents and that the Town would look into this in the future.

4. First Reading: ORDINANCE 2021-001
AN ORDINANCE OF THE TOWN OF HOWEY-IN-THE-HILLS, FLORIDA
AMENDING THE CAPITAL IMPROVEMENTS ELEMENT IN CHAPTER 8 OF
THE TOWN'S COMPREHENSIVE PLAN BY UPDATING THE FIVE-YEAR
SCHEDULE OF CAPITAL IMPROVEMENTS TO INCLUDE ESTIMATED
CAPITAL IMPROVEMENTS FOR FISCAL YEAR 2020-2021 THROUGH
FISCAL YEAR 2024-2025 PURSUANT TO THE REQUIREMENTS OF
CHAPTER 163 OF THE FLORIDA STATUTES; PROVIDING FOR CONFLICT,

8. Discussion: Cemetery Fees.

Mayor MacFarlane explained this item was about the Town's Cemetery, Taylor Memorial Cemetery and how it currently functions. The town's cemetery is not a perpetual care cemetery, but it is well managed. The town needs to look at our costs and fees and see how we compare to other local municipalities. The town should also look at if we should open the sale of lots to the public which are not residents.

9. Discussion: Allowing the use of credit cards in Town Hall via Square with a markup to cover fees.

Mayor MacFarlane spoke about how Town Hall currently did not take credit cards at Town Hall. The town would be looking into taking credit cards at town hall, however the markup fees that credit card companies charge the town would be pushed down to the owner of the card. The Town Clerk would be looking into how we can implement a system with our Black Mountain Software Cash Receipting system.

Mr. John Ernest suggested that many residents had wanted to name the alley between Holley St and Central Ave. Mayor Pro-Tem suggested that we have a "name the alley" contest. Mrs. Wagler volunteered to head up the project of creating a contest to name the alley. Mr. Ernest also gave an update on the Downtown Sewer Project which will be completed by August.

Councilor Gallelli reminded everyone that the date for her next Social Distance Meet would be February 27th, at 10am. The Meet up would be at the gazebo at Griffin Park and the topics will include residents with businesses and ways to conserve water. She also announced that a speaker from LCWA (March 11, 2021 at 7pm at the LEC) would come speak to residents

about water conservation and manatees in the Lake Harris Chain. Also, because we are having this presentation, we will be able to add it to our CUP permit.

Mayor MacFarlane

Mayor MacFarlane stated that she is working with Jen Bolling on drafting a Resolution about Water Conservation. Mayor MacFarlane met with Tavares town administrator (James Dillion) who was helpful and wants to collaborate. The town is also looking at working with two consulting agencies in respect to finding and securing grants. Mayor MacFarlane also gave an update on CARES funding and how we are reallocating funds. Starting in March, Town Hall will be closing on Fridays to the public, except for appointments.
